- Meeting Minutes: The minutes from the October board meeting were approved as written.
- Treasurer's Report: The financial statement was distributed and approved.
- Division Reports:

There are no major problems. The 3.5- Division reported the combining of the two Park Meadow teams into one team. Due to the large number of teams in the Silver Division, they are encouraging their captains to schedule their 26<sup>th</sup> and 27<sup>th</sup> matches. Kelly stressed that it is the responsibility of all captains to play strength as they see it.

- Heat Exhaustion/Heat Stroke: A discussion was held concerning play in the extreme heat of this October which caused some health issues for a few players. To stay hydrated in the heat, drink 32 oz. two hours before a match – good drinks would be Gatorade, Smart Water, etc.

It is recommended that all players keep emergency paper in their tennis bags listing name, address, contact information, medication, copies of insurance cards, etc.

Jenny Clark-King will prepare a form for the website which players can download and complete for carrying to their matches.

All captains should be aware if they have someone on their team with health issues so that they can make a decision to play or not play or retire. Players need to take responsibility on how to manage their game.

Kelly summarized the discussion saying it is difficult to make a policy to address heat as each person tolerates heat at a different level. Our recommendations are that captains work with their players, but ultimately it is the player's responsibility on how they monitor their game on when to continue play or retire.

- Website Suggestions: To further improve our website, individual items were reviewed relative to the areas where they should be found by players, captains, and officers.
- Proposed Rules Changes: Gloria Nelson reported that the committee will meet the third week in January and consist of a cross section of division officers. If players, captains, or officers have any requests, they should be forwarded to all four executive officers by January 15 at the latest.
- News-Press Article: Gloria Nelson and Sue Morgan have submitted an article on our league to the newspaper. Gloria will let us know by email when the article will print.
- USTA Friend of Court books were distributed to all officers. The divisions may want to purchase copies for their captains and/or players since our league follows USTA rules. The 2010 books will be available in February or March.
- Monthly Drawing: This month Janice Layman received the gift certificate drawn at random from participating officers.
- The meeting adjourned at 3:49 p.m.
